The Game may not be run for any commercial purpose under this agreement. Agreements for commercial runs may be made with MSS Management Simulation Systems AB and do not belong to the academic co-operation treated herein

The contract is concluded for an initial period of 3 years and may be terminated at the earliest on July 3, 2006. After this date, the contract may be terminated at the end of a year.
